
Public Health Nursing

- Definition
 - Public health nursing is the practice of promoting and protecting the health of populations using knowledge from nursing, social, and public health sciences
 - American Public Health
 Association, Public Health
 Nursing Section, 1996



21st Century Public Health Nursing

- Emphasizes:
 - Core Public Health Functions
 - Essential Services of Public Health
- Proactive in approach to health concerns
 - Impacting policy (laws)
- Consider multiple determinants of health
 - Individual
 - Societal and environmental



Core Public Health Functions

Assessment

 Systematic data collection on the population, monitoring the population's health status, and making information available about the health of the community

Policy Development

 Efforts to develop policies that support the health of the population, including using a scientific knowledge base to make policy decisions.

Assurance

 Making sure the essential community oriented health services are available. Making sure that a competent public health workforce is available.



Essential Public Health Services

 Represents the obligations of the public health system to implement the core functions

 Developed by a working group of federal agencies and organizations via U.S. Public

Health Service

Consists of 10 essential services



Essential Public Health Services

Monitor health status to identify community health problems.

Diagnose and investigate health problems and health hazards in the community.

Inform, educate, and empower people about health issues.

Mobilize community partnerships to identify and solve health problems.

Develop policies and plans that support individual and community health efforts.

Enforce laws and regulations that protect health and ensure safety. **Link** people to needed personal health services and assure the provision of health care when otherwise unavailable.

Assure a competent public health and personal healthcare workforce.

Evaluate effectiveness, accessibility, and quality of personal and population-based health services.

Research for new insights and innovative solutions to health problems.

Characteristics of Public Health Nursing

- The client or unit of care is the population
- Focus on greatest good for greatest number
- Client (population) equal partner
- Primary prevention
- Environmental, social, economic conditions
- Reach out to all who might benefit
- Optimal use of available resources


Public Health Interventions "Wheel"




